

# **PUBLIC NOTICE**

**ANNUAL HYDRANT FLUSHING DURING WEEKS OF APRIL 26th AND MAY 3<sup>rd</sup>, 2021  
MONDAY thru FRIDAY from NOON until 10:00 PM**

**THE KALAMAZOO LAKE SEWER & WATER AUTHORITY (KLSWA) WILL BE FLUSHING HYDRANTS WITH THE MAJORITY OF FLUSHING OCCURING THE WEEK OF APRIL 26TH. ADDITIONAL FLUSHING COULD OCCUR THE WEEK OF MAY 3<sup>rd</sup> , IF NECESSARY. IT IS LIKELY THAT YOU WILL EXPERIENCE DISCOLORED WATER AND POSSIBLY SEDIMENTS. PLEASE CHECK YOUR WATER FOR DISCOLORATION BEFORE DOING LAUNDRY OR ANY USE THAT MAY ADVERSELY BE AFFECTED BY DISCOLORED WATER OR SEDIMENTS. AVOID USING ICEMAKERS, HOT WATER, WASHING MACHINE, DISHWASHER OR ANY FIXTURE FROM A WATER TREATMENT OR FILTER. WHEN YOU EXPERIENCE DISCOLORATION, RUN ONLY THE COLD WATER THROUGH A BATHTUB OR AN OUTSIDE FAUCET THAT IS NOT PLUMBED THROUGH A WATER TREATMENT DEVICE, UNTIL THE WATER IS CLEAR. YOU MAY WISH TO BY-PASS YOUR WATER TREATMENT DEVICE OR FILTERS TO PREVENT THEIR FOILING. ONCE THE WATER IS CLEAR, YOU MAY ALSO WISH TO OPERATE THE WASHING MACHINE and/or DISHWASHER THROUGH AN EMPTY CYCLE BEFORE WASHING ANY CLOTHES OR DISHES. THE FLUSHING OF HYDRANTS IS TO CLEAR THE WATER SYSTEM OF IRON SEDIMENT DEPOSITS, TO INSURE USE OF HYDRANTS FOR FIRE SUPPRESSION FUNCTIONS AND TO TEST THE WATER SYSTEM.**

**WE APPRECIATE YOUR PATIENCE DURING THIS NECESSARY WATER SYSTEM MAINTENANCE IN DOUGLAS, SAUGATUCK, SAUGATUCK TOWNSHIP, the GOSHORN LAKE area of LAKETOWN TOWNSHIP.**
